2. SEIP Tranche 2 is supporting the modernization of three (3) Technical Training Centers (TTCs) (Bangla-German, Dhaka, Khulna and Sylhet) under the Bureau of Manpower, Employment and Training (BMET) in the Ministry of Expatriates' Welfare and Overseas Employment, in collaboration with the Korea International Cooperation Agency (KOICA). For this modernization, SEIP will finance the upgrading of infrastructure (training facilities and equipment) in 3 TTCs, whereas KOICA will support the overall planning for upgrading and implementation of training programs. Based on the feasibility work carried out by KOICA and SEIP, terms of reference (TOR) has been prepared for recruitment of a design and supervision consultancy (DSC) firm, which will develop the detailed designs of upgrading works (including new construction) and bid documents for civil works of 3 TTCs. The objective of this assignment for an engineer is to provide technical inputs and support for bid evaluations during DSC recruitment and civil works contractors, as well as to coordinate closely with KOICA for all design works of infrastructure facilities in TTCs and bid preparations for contractors.
